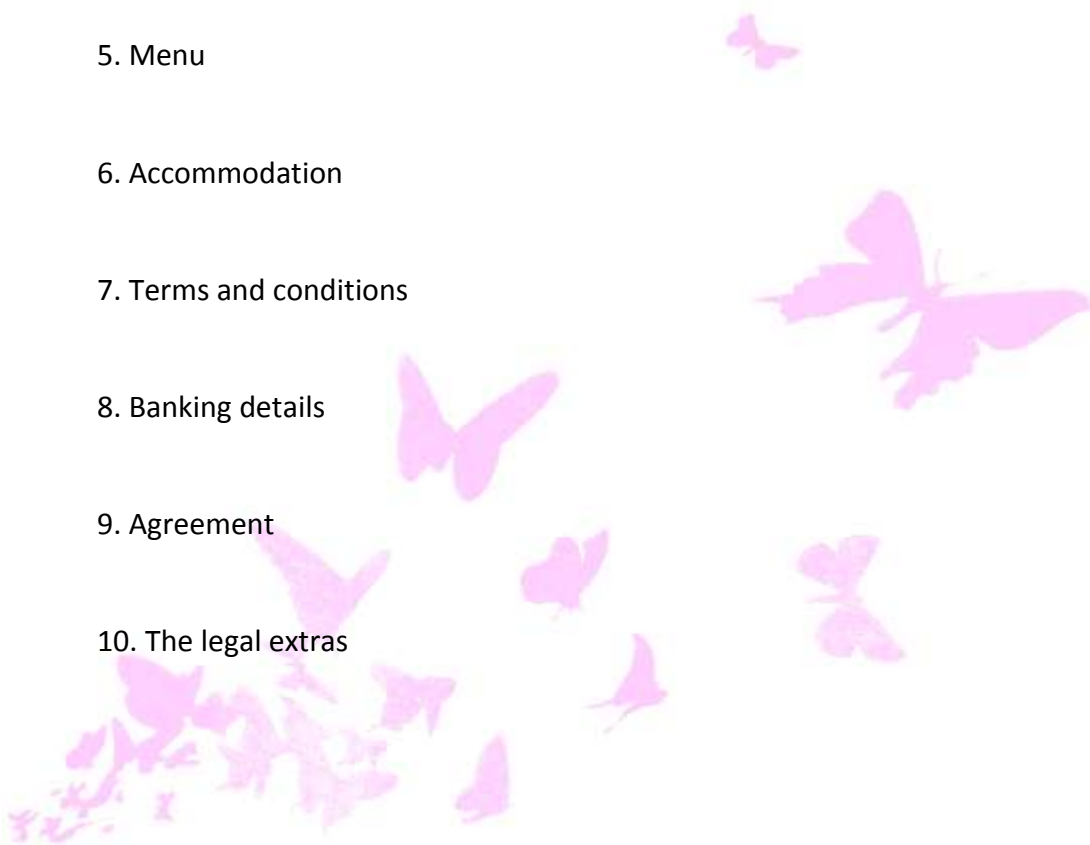

TERMS AND CONDITIONS

These terms and conditions are applicable to all functions held at Bayede!, and are binding on the person making the booking (the host) upon confirmation of the reservation by payment of the deposit.

1. Provisional bookings

We hold provisional bookings for seven days after signing our booking form. If no deposit or proof of payment has been received within this period, we shall have the right to accept another booking without further notice.

2. Booking confirmation and deposit

A deposit is required to guarantee the booking of the venue. The deposit shall be the venue hire fee plus the total food price per head.

3. Payment

Full settlement is due on presentation of the final invoice. Deposits will be deducted from the bill. Management reserves the right to charge for damages to the building or any other property.

4. Service Charge

A standard 10% service charge will be added to the final food and beverages bill to parties of 6 or more.

1. The Owners, Management and Staff members do not take any responsibility for any of the guests or host's belongings or any injury, damage or loss suffered by any persons, and damage to any such belongings and the host waives any claim it may have.
2. Please note that our facilities are non smoking but a smoking area will be provided.
3. Right of admission reserved.
4. All décor and flowers on the tables will be removed by staff and must be collected no later than 10h00, the following day unless by prior arrangement with management.
5. All menu and food prices include VAT at 14% and are subject to availability. Prices and Menus are subject to change due to inflation, but the client will be notified of this.
6. Prices are subject to escalation after ninety (90) days from date of deposit.
7. The deposit paid only guarantees availability for the date originally booked. It is ONLY transferable to another date if the other date is available.
8. Anything hired on behalf of the client will be charged directly to the client, plus a 10% handling charge.
9. All decorations to be discussed with management to ensure no damage will be done to the venue.
10. All deliveries to be cleared with management for proper access to the venue.
11. Bayede! and Eikendal Vineyards does not accept responsibility for any loss or inconvenience due to power failures or natural causes.
12. All damage to the venue, cutlery, crockery, linen, glasses and furniture will be charged directly to the client.
13. Bayede! and Eikendal Vineyards does not accept responsibility for loss or damage of any item left in the venue after the function.
14. Bayede! and Eikendal Vineyards or any of its employees do not accept responsibility for loss or damage by whatsoever cause.
15. Décor and set-up must be completed two (2) hours prior to the schedule time of commencement of the event in order to allow for final cleaning.
16. Weather - Bayede! and Eikendal Vineyards reserves the right to use our own discretion to move any outside events indoors if we consider the weather conditions to be unsuitable for outside
